- B. Bank Update
  - a. The BES Executive Committee has faced challenges in identifying a bank to host section accounts and allow for easy transition of account names as officers transition. Currently, BES has a Bank of America account which requires all account holders and new account holders to a branch office in-person. This can be difficult when officers live on opposite sides of the country (i.e., Massachusetts and Oregon) such is the case with BES. BES contacted several other Section officers and identified that a similar challenge was being faced by others. No ideal banking solution was identified to date and the BES Executive Committee has

discussed whether AFS at large could address this issue. Perhaps by identifying a bank that might offer virtual account holder transition process and thus many AFS Sections are likely to switch banks if this a more convenient option was made available.
