- The 2009 Annual Meeting of the Colorado/Wyoming Chapter of the American Fisheries Society will be held in Loveland, Colorado at The First National Bank East Exhibition Hall, February 23-26, 2009. - It's time to begin thinking about the upcoming CO/WY AFS Annual Meeting. This year's plenary session will be titled "Incorporating Climate Change into Local Management Decisions", so presentations related to this topic are appreciated. Final deadline for presentation and poster abstracts is February 13, 2009.

Abstracts for contributed papers and posters should be prepared as a MS Word or WordPerfect file in 12 point, Times New Roman font, left aligned and include the following information.

1. A brief descriptive title.
2. Names, addresses, telephone and FAX numbers, and e-mail addresses for all organizers. Presenter must be clearly identified.
3. An abstract of 350 words or less.
4. Indicate whether presenting a poster or oral presentation.
5. Indicate if presenter is a student.
6. Indicate length and width of poster.
