# S.F. SNIESZKO DISTINGUISHED SERVICE AWARD, SPECIAL ACHIEVEMENT AWARD, AND SNIESZKO STUDENT TRAVEL AWARDS

The time has come to nominate individuals for S.F. Snieszko Distinguished Service Award, Special Achievement Award, and Snieszko Student Travel Awards. For those of you that don't know what these awards stand for, the Snieszko Distinguished Service Award is the highest award in the FHS presented for the purpose of honoring individuals for outstanding accomplishments in the field of aquatic animal health. This is a career award and may be given to more than one person in a year but is not necessarily awarded every year. The **Special Achievement Award** is presented to a FHS member who has made a significant accomplishment in the fish health field regarding a new discovery, diagnostic method, publication, etc. This award is for a one-time accomplishment and may or may not be given out every year. This award may be given for: (1) a unique contribution to the fish health field (such as a new diagnostic tool, a new technique to control disease, etc.), (2) a significant research accomplishment, or (3) outstanding leadership in resolving a major aquatic animal health problem. The achievement must meet high standards of science and survive peer review. And finally, the Snieszko Student Travel Awards are awarded to one or more students yearly to defray travel to the FHS meeting and to present a talk in the aquatic animal health field.

This year we do have some exciting changes in the **Snieszko Student Travel Award**. For one, the Fish Health Section has made available extra funds to assist approximately 10 foreign and domestic students to travel to the 2010 International Symposium of Aquatic Animal Health in Tampa, FL in September. In addition, all students that apply to present at 2010 ISAAH will have their Fish Health Section dues paid for one year. For students that are not currently members, their 2010 dues will be paid, and for all current student members, their 2011 dues will be paid. Please follow the guidelines (attached) on how to apply.

All nominees (except for student travel awards) must be FHS members. Nominations will be accepted until 5PM (EST) May 2, 2010.

**SNIESZKO STUDENT TRAVEL AWARDS FOR 2010 ISAAH** - a sum of up to \$1000 awarded to one or more students yearly to defray travel to a professional meeting to present a talk in the aquatic animal health field. The requirements and procedures for selection of student awards are as follows:

- A. Basic Requirements from Student Applicants
  - a. Letter of application and statement of any special financial circumstances (i.e., not supported by a stipend, etc.)
  - b. Curriculum vitae must be submitted along with three letters of recommendation.
  - c. Itemized budget on how money is to be spent, i.e. travel, meals, lodging and registration.
  - d. Copy of abstract of paper to be presented.
- B. Judgment Criteria

### Weight

a.	Quality of abstract	50
b.	Significance of/interest in the research	5
C.	Academic achievement	10
d.	Professional achievement	10
e.	Financial need	25

- C. Procedure for Selection
  - a. Request for application announced in the October and January issues of the Newsletter with a deadline.
  - b. Chair of the Awards Committee receives the application packets and sends a letter of receipt to each applicant.
  - c. Applicants are ranked according to total scores obtained from the points earned in the Judgment Criteria.
  - d. The number of applicants awarded travel funds will depend upon the amount of interest available on the account and the ranking and number of applicants. The intent is to fund as many students as possible, beginning with the highest ranked, until the interest money runs out.
- e. Committee decisions for awarding the travel funds are relayed to each applicant by letter and the AFS office is notified to send checks to the successful

candidates. The meeting program chair is also notified of the successful applicants such that footnotes on their printed abstracts

### **FHS NOMINATIONS - REMINDER**

The time has come to nominate individuals for our 2010 section election. Positions open to election include positions in the Professional Standards, Technical Standards, Policy/Position Development, and Nominating and Balloting committees as well as Vice President. **PASSINGS** (from Rocco Cipriano)

In Memoriam:

Dr. Robert E. Putz passed away on December 13, 2009 at his home near Shepherdstown (WV). Bob, as he was known to his friends, described himself as "an average Joe with maybe above average vision." In his 74 years of life, Bob wore the hats of scientist and administrator with the US Fish and Wildlife Service. He had a passion for life which exuded into his ardor for protecting this nation's fish and wildlife by promoting policies of sound management. Bob began his tenure with the USFWS as a parasitologist at the Eastern Fish Disease Laboratory (Leetown, WV) in 1962 under the tutelage of Dr. Stanislaus S. Snieszko. At that time, much of his research was devoted to the study of

Whirling Disease. After Bob left the bench, he held numerous positions within the highest levels of the USFWS including tenures as the Associate Director for Research, the Associate Director for Wildlife Resources, and the Regional Director of the USFWS Region 1 - Alaska. Bob's vision included the transformation of the Eastern Fish Health Disease Laboratory into the National Fish Health Research Laboratory and the development of the National Fisheries Center - Leetown (predecessor to the Leetown Science Center). In addition to the NFHRL, Aquatic Ecology Laboratory, and the Fisheries Academy (precursor to the National Conservation Training Center (now at Shepherdstown, WV) that were located at Leetown, Bob's vision included the development of other satellite laboratories in Wellsboro (PA), Cortland (NY), Turners Falls (MA), Hagerman (ID), and Gainesville (FL). Upon his retirement from the USFWS, Bob worked with The Conservation Fund to establish The Freshwater Institute (Shepherdstown, WV) in his continued efforts to conserve and protect our nation's resources. Bob's energy and passion for life went far beyond his professional career. He will be missed by all who called him friend.

The 35th Eastern Fish Health Workshop will be dedicated to the memory of Dr. Robert E. Putz - "...an average Joe with maybe above average vision..."

# POST DOCTORAL RESEARCH OPPORTUNITY IN HERRING DISEASE ECOLOGY
