#### MESSAGE FROM THE PRESIDENT

#### ....IN THE NEWS

Several days of southern Florida vacation followed Carl Sullivan's participation in the Florida Chapter annual meeting. He used the time to (1) visit Introduced Fish Section president Paul Shafland's lab in Boca Raton, (2) take a fisheries-oriented tour of the Everglades National Park, (3) join Eric Prince in a Gulf stream search for hungry dolphin and pursue a life-long ambition of catching a tarpon in the famous fishing flats of the Gulf off Paul Shafland extended himself to introduce him to peacock bass angling and, even though they saw these, they wouldn't cooperate. Jim Tilmant introduced Sully to the wondrous wetland resources of Everglades National Park and Eric Prince put him in direct contact with several 15-20 pound dolphin which cooperated beautifully. Ten miles south of Marathon Key he spent two full hours in mortal combat with a 100-plus pound tarpon but, sad to say, his life-long ambition to land one of those aerial monsters The tarpon left Sully rubber-legged and remains unfulfilled. exhausted but he has vowed to get'em next time.

Names of Decapods is the shorthand title of the latest AFS reference book on the names of aquatic animals. Its full title, "Common and Scientific Names of Aquatic Invertebrates from the United States and Canada: Decapod Crustaceans", identifies the book the Society's standing committee on Names of with Invertebrates, chaired by Donna Turgeon. Under general direction of the "Names" committee, the decapod book was created by a special group of the Crustacean Society headed by Austin Williams of the The new work lists all 1,600+ decaped Smithsonian Institution. species currently recognized in marine and fresh waters of Canada and the USA, and assigns unique vernacular names to most of them. These names have been adopted as editorial standards for AFS publications. "Names of Decapods," AFS Special Publication 17, has 77 pages and 4 color plates. North American Fish Fauna Decline: Researchers report that during the past 100 years, 3 genera, 27 species, and 13 subspecies of fishes from North America have become extinct, nearly half since 1964. In reports published by the American Fisheries Society, researchers said the listing underscores concerns regarding loss of biological diversity -- "a problem that is not restricted to the tropics, but is a concern in every state and province of the continent." According to the study, "The health of aquatic habitat continues to decline. A major commitment to the conservation of entire ecosystems, rather than the inconsistent recovery efforts for individual species, is needed to reverse this trend." Wetlands Science: The EPA has released a publication resulting from research initiated on wetland creation and restoration. Issued in two volumes, the first provides regional summaries of "lessons learned" and recommends research priorities; the second covers topics such as hydrology, management techniques, and planning. Key conclusions:

- ---Practical experience and available research findings on restoration and creation of wetlands are limited for most wetland types and vary regionally.
- ---Most projects do not have specific goals, complicating efforts to evaluate "success." Partial project failures are common.
- ---Monitoring of wetlands restoration and creation projects has been uncommon, just ask David Crewz, Florida Marine Research Institute. Contact AFS headquarters for the reference.

Limits on Sharks Expected July-August: Proposed regulations for a shark fishery management plan in U.S. Atlantic, Gulf, and Caribbean waters are scheduled for publication in April. Final regulations are expected in July or August. Demands for sharkfin soup in the Orient, shark meat in the U.S., sports fishing and medical research all are blamed for contributing to the shark decline. NOAA's National Marine Fisheries Service (NMFS) said sharks are "in trouble" from 10 years of overfishing. A commercial first-year limit of 5,800 metric tons is proposed. Recreational limits would be two shark per boat-trip or four sharpnose sharks per angler per trip. Further info: Paul Leach (813) 893-3322.

magazine features a range of articles and information on Florida. The program will analyze data to predict demands on fishery resources, develop a national conservation network, and distribute data through the coalition network to affect local management policies. The Creel and Angler Survey Symposium, sponsored by AFS and the U.S. Fish and Wildlife Service, attracted 270 registrants to Houston during March 26-31. The Program Committee, chaired by Bob Ditton, organized a diverse array of 70 papers on the design, execution, and analysis of surveys for all aspects of fisheries Mac McCune and Nick Parker took care of the management. arrangements and entertainment, which featured Mexican and seafood dinners, a rodeo, and memorable bus rides. Administrators, biologists, sociologists, statisticians, and economists interacted intensely during the 4.5 days of formal and informal sessions, and all comments about the conference were enthusiastically favorable. Authors presently are revising their peer-reviewed manuscripts, which will be edited for publication by Dan Guthrie of the AFS editorial staff. The conference proceedings should be available early next year.

## CALL FOR PAPERS FLORIDA LAKE MANAGEMENT SOCIETY


Notice of meeting and first call for papers, Florida Lake Management Society, Second Annual Meeting, September 26-27, 1990, Orlando, Florida.

AFS PRO CLUB - PROFESSIONALS RECRUITING OTHERS. 
