10-13th February 1998 Fayetteville Hilton and University of Arkansas Center for Continuing Education

The Oklahoma Chapter of the American Fisheries Society will meet with the Arkansas and Kansas chapters at the Fayetteville Hilton, in the historic downtown area of Fayetteville, Arkansas. The meeting agenda includes, workshops, technical secessions, Arkansas River Mini-Symposium, information exchange secession and chapter business meetings. There will also be a student/professional mixer and a banquet. A separate mailing to preregister for the meeting and workshops will follow.

The downtown Fayetteville is a revitalize area of approximately 10 square blocks and includes; the Walton Art Gallery, a variety quaint specialty shops (Valentine's Day follows the meeting very closely), restaurants, and quite a number of interesting looking bars (for your own exploration). By February a microbrewery also may be in operation. All the above and the Hilton can be reach by Trolley Car at any time of day or night (the latter is as yet untested). Other regional attractions include an Air museum, Prairie Grove and Pea Ridge Civil War Parks, Devil's Den State Park, and fishing opportunities on Beaver Lake and the upper White River: more to follow.

NUTS AND BOLTS OF THE MEETING

The official meeting location is the Fayetteville Hilton even though the actual sessions will be held in the adjacent Center for Continuing Education. Registration for the meeting is \$40 and includes a ticket to the banquet. To make reservations call 1-800-445-8667 and identify yourself as an AFS meeting participant. Chapter members may reserve rooms at a flat rate of \$54 + tax /night - multiple occupancy. Sixty rooms have been blocked for the meeting at this special rate until January 23, 1998. Meals are available in the hotel at reasonable prices. Numerous restaurants are also located within 4 blocks of the hotel.

Bill Stark is the program coordinator and is requesting submissions to the technical secessions. Of special interest are topics from those of you working in the Arkansas River Basin; however, submissions on any subject are welcomed and encouraged. Titles, authors (if more than one, please note which will be presenting), and abstracts (250 words maximum) may be submitted (snail mail, fax, or e-mail) no later than January 9, 1998 to Bill at the following:

We have two workshops scheduled as follows:

1.) Identification and Quantitative Sampling of Freshwater Mussels. Leaders are Dr. Caryn Vaughn of the University of Oklahoma; Mr. John Harris, Arkansas Highway and Transportation Department, Environmental Division; and Mr. Brian Obermeyer, Aquatic Resources Specialist, Fort Riley, Kansas. All the above are experts in the identification of live mussels and mussel shells and will provide an extensive hands on identification workshop. Registration is \$30 (\$15 for students). Wait for preregistration forms to follow in a subsequent mailing.

2.) Age, Growth, and Production of Fishes: New Science and Technology. Leader is Dr. John Casselman, Glenora Fisheries Station, Picton, Ontario. Because of the depth of subject matter and and novel technology presented, this workshop is more protracted than we usually undertake at our annual meeting, but nonetheless promises to be well worth the time. The workshop will present two "cutting edge" systems; a Calcified Structure Age Interpretation System (CSAIS), and a Calcified Structure Age-Growth data Extraction System (CSAGES). These systems not only more objectively identify putative temporal marks on calcified structures in fishes, but allow for a more

thorough analysis of these data. The final component will compare and contrast methods of estimating fish production from aging data using user friendly software (EXCEL). The workshop includes software, computer time, and practical demonstrations. The tentative schedule is from Thursday, Feb. 12 at 1:00 thru early afternoon on Feb. 13 depending on travel logistics. At this time, registration is \$90; however, the program committee is attempting to get the workshop subsidized, so the cost to those attending will likely be lower. Preregistration material will follow in a subsequent mailing.

ANGLERS TO ENJOY A NEW TROUT AREA IN NORTHEAST

Oklahoma anglers will have more trout fishing opportunities this fall, thanks to a cooperative effort between the Oklahoma Department of Wildlife Conservation and the City of Pawhuska. The trout season at Pawhuska opened November 1 along with the Department's other wintertime trout areas, and it will run through March 31, 1998.

Action to create the new trout area was taken by the Oklahoma Wildlife Conservation Commission at its regular September meeting held in Oklahoma City. The Department's trout program continues to increase in popularity among anglers, with more than 33,000 trout licenses sold during 1996. Overall, the program pays for itself, with trout license revenues offsetting the expense of purchasing trout and managing the trout fisheries.

RESERVOIR RESEARCH SCHOLARSHIP TO BE AWARDED

The Reservoir Committee of the Southern Division AFS announces the creation of the Robert M. Jenkins Memorial Reservoir Research Scholarship in honor of one of our professions true pioneers in fisheries research and management. Two \$1,000 scholarships will be awarded annually to students conducting

reservoir-related research in the southeastern United States. Funding for a second year will be available contingent upon satisfactory academic and research performance. Scholarship recipients will be required to present the results of their study to the Reservoir Committee or at a conference where the Committee is holding a regular meeting. The committee will also provide travel assistance of up to \$500 each if student travel funding is not available.

Interested students or professors should contact Gene Gilliland (405/325-7288; gene_gilliland@mail.fws.gov) for application procedures and selection criteria that will be used in awarding the scholarships. The Committee expects to announce the first scholarship winners at the Southern Division Mid-year meeting in Kentucky in February, 1988.

SMALLMOUTH BASS TAKE OVER AT LAKE EUFAULA

For the first time, natural reproduction of smallmouth bass was documented in two locations at Eufaula Reservoir. The findings indicate that smallmouth bass have become established in the lake, and anglers can expect potentially exiting fishing in the future.

The Wildlife Department's efforts to introduce reservoir-strain smallmouth bass at Eufaula began in 1992 with an experimental stocking of smallmouth fry. Fingerlings raised in nursery ponds at the lake have been stocked each year since then. The initial stockings concentrated in areas of the lake where reproduction

was documented. Smallmouth bass fingerlings are now being stocked in other areas.

Smallmouth bass prefer rocky areas and clear water. Noted for its fighting ability, the smallmouth bass often jump out of the water and make dragburning runs when hooked. Reservoir-strain




