We are also in need of someone to take charge, and I mean CHARGE!!! of the pond management seminar program to get it off the ground in a larger way. At the last meeting, we all agreed that the pond books we invested in would move a lot faster if we could get this program going. I suggest trying to get at least two seminars in each region over the course of this next year. We have a lot to gain here not only financially, but also in providing a positive and professional forum for us to interact with a significant number of aquatic resources, a priori (i.e., before you are cornered in a boat somewhere trying to explain large-scale management objectives to someone that is convinved their misinformation is gospel). We also may be able to coordinate these seminars such that the location would benefit some of the companies or mom and pop outfits that have supported our activities over the years. In this way, we can avoid the appearance of coming "to the well" too often and possibly even give something back to these supporters. Finally, for those that require loftier goals, it will aid in "stamping out the flames of ignorance" with regard to pond management. All of the above are worthwhile goals for this program.

Enclosed is a ballot that asks the membership to vote on accepting the bylaws of the student subunit as part of our own and in doing so making the Oklahoma Student Chapter of the American Fisheries Society an official entity. This has been a dream of the chapter for some time and the work of an outstanding core of students primarily at Oklahoma State University. Speciel recognition is due Conrad Toepfer, Craig Pauker and Jim Long who provided the necessary longevity across their academic careers, as well as, the resourcefullness and tenacity to bring this idea this close to reality. I urge the membership to give these bylays unanimous approval.

Finally, as some may already know, I will be leaving Oklahoma in August 1998 to take a similar position at Fort Hays State University. Although the opportunity to relocate near aging family members is irresistable, it is with no small degree of reluctance that I will be leaving my position at Southeastern Oklahoma State University and the state of Oklahoma. PRESIDENTS MESSAGE

Greetings,

How are things in the fisheries world? It has been a little while since our last newsletter and there has been some changes as to who is editing and publishing The Lateral Line. The Student Sub-chapter has graciously volunteered to take this task on. Thank you very much. Also, in the way of an update, Dr. Bill Stark has taken a teaching position in Kansas. We wish him well. However, this leaves me as both President-Elect and President. I have been assured that this has happened before. So we will handle it as we always have. A meeting is being planned for the 3^{rd} , 4^{th} , and 5^{th} of February, 1999 at Roman Nose State Park, near Watonga.

I have had two items of business cross my desk. The first, is a request for a statement of endorsement for the Conservation and Reinvestment Act. The Act, if put into law, would redistribute Outer Continental Shelf Revenues toward wildlife and outdoor conservation efforts. If anyone would like a copy of the Act, give me a call or e-mail me and I will send you a copy of the information I received.

The second piece of business was an e-mail from Reggie Harrel, President of the Southern Division of the American Fisheries Society. The e-mail was sent to all chapter presidents. He has some concerns about the Southern Division's participation in the Southeastern. This is a quote from his correspondence. "This year we had only 13 papers accepted for presentation-publication. This is embarrasing. I can't believe we have only 13 notable efforts ongoing in our division that are worthy of submission for publication to showcase what our membership is doing." Reggie has set up an ad hoc committee to address how we as the Southern

Division can improve our presence at the Southeastern and our contributions to the Proceeding.

The committee will be asking questions such as "Why are our publication submissions down?", "Why are our members not submitting papers to the Southeastern?", "What can be done to encourage submissions?", etc. If anyone has an input on these questions, please send it to me and I will draft a response and send it in.

As the meeting is a short time off consider this newsletter a call for papers also. I encourage all interested to present. Please have titles to me by the 27^{th} of January.

The Oklahoma Chapter of the American Fisheries Society will hold its 19th Annual Meeting at Roman Nose State Park near Watonga, OK. The meeting is still in its early planning stages but will offer technical sessions, a student/professional mixer, and chapter business meetings. Registration will be on-site (no preregistration has been scheduled).

Roman Nose Resort Park is located 8 miles north of Watonga on state highways 8 and 8A and 81 miles northwest of Oklahoma City. It is located near Lakes Watonga and Boecher. This area was once a favorite of the Cheyenne tribe of Native Americans and is now a scenic retreat set on a canyon bluff overlooking ancient mesas. Towering cedar, buffalo grass and wild blue sage add to the beauty of this legendary setting, and to the enjoyment of numerous recreational activities.

Roman Nose Resort features 83 acre Lake Watonga, 515 park acres, a resort lodge with 47 guest rooms, 10 cottages, 3 meeting rooms, the Redbird Restaurant, 2 camping areas, tipis, and the Spring of Everlasting Waters (an underground river system flowing 200 gallons per minute). There is also a 9 hole, 35 par golf course with a natural hazard on the 7th hole known as "Canyon Hole". Located nearby is the Watonga Cheese Factory, Alabaster Caverns State Park, and the Chisholm Trail Museum.

Teaming with Wildlife

On October 7, the US Congress introduced two Conservation wildlife-related bills: the and (House Bill 4717) and the Reinvestment Act Reinvestment and Environmental Restoration Act. These bills will dedicate a percentage of offshore oil and gas revenue for coastal impact assistance (Title I), land-based recreation (Title II), and wildlife conservation (Title III). In Oklahoma, the bills are expected to provide 5-7million dollars annually for wildlife conservation. The house bill dedicates 10% of funds to wildlife conservation, while the Senate bill dedicates 7%. Title III funds will be administered under the Pittman-Robertson framework but can be used to all fish and wildlife species. Pallid sturgeon reintroduction in North Dakota

The pallid sturgeon was listed as endangered in 1990. After it was determined that the population was headed toward extinction, because the wild population had not reproduced in 20 years and because of habitat degradation. As a recovery strategy, about 750 pallid sturgeons were bred in captivity from wild sturgeon captured in the Missouri River. They were released in the Yellowstone and Missouri rivers near Williston, ND in August. As well as a stocking program the US Fish and Wildlife service is working to restore breeding habitats to allow them to spawn in the wild.

AFS Sponsors 1st Student Writing Contest

The American Fisheries Society is hosting its first ever student writing contest "to recognize students who do an excellent job communicating the value of fisheries research to the general public." Undergraduate and graduate students are invited to submit a 500- to 700-word article describing their research in a manner understandable by the general public. Reserch may be in progress, completed, or in the planning stages.

The top three winners will be invited to the AFS annual meeting (at the winner's expense) where their articles will be displayed at the poster session. Winners will also be given a plaque recognizing their accomplishments and the their articles will be published in *Fisheries*.
