Executive Director Doug Austen was present and thanked everyone for their continued support of AFS and gave an update on the upcoming annual parent society meeting in Spokane, WA.

President Williams presented the Spring EXCOM meeting agenda.

SDAFS President Report

President Cindy Williams updates the group on the status of the 2022 SDAFS briefing book and indicates that there are still missing reports from state chapters and technical committees. President Williams remembers Past-President Tom Kwak, who passed away unexpectedly in November 2021. She notes that this is the first time that an acting EXCOM member has passed away during service to SDAFS and highlights the impact that Tom had on the society and on it's individual members.

The rest of President William's report stands as written.

SDAFS Officer Report

President-Elect Jason Olive began by thanking Dennie Reicke and Amy Cottrell for their continued work on the SDAFS list-serve. He noted that he provided oversite for the 2022 annual SDAFS meeting and organized the past president's luncheon. He also highlighted his involvement in the AFS Governing Board and local state chapters of AFS.

The rest of President-Elect Olive's report stands as written.

Vice President Mark Rogers introduced himself. He indicated how honored he felt to hold a position on the SDAFS EXCOM. He also congratulated SCAFS on a great job putting together the 2022 annual meeting even with the difficulties encountered by the global pandemic, COVID-19.

The rest of Vice President Roger's report stands as written.

Past-President Tom Kwak passed away while serving his final term on SDAFS EXCOM. It is a huge loss for the society as a whole and he will be greatly missed. Past-President Wes Neal stepped up to perform those duties left by Tom's passing. President Williams thanked Wes for his willingness to help EXCOM in such a difficult time.

Past-President Kwak's / Neal's report stands as written.

Secretary-Treasurer Jessica Baumann's reports were handled individually. She noted that the meeting minutes from the 2021 EXCOM meeting are posted on the SDAFS website and were released in the SDAFS newsletter.

Secretary-Treasurer Baumann provided an overview of the 2021 budget. Several income and expense items were highlighted, including \$2,000 in AFS rebates. It was noted that the 2021 AFS membership rebates will be included in the 2022 budget due to the Parent Society switching payment forms from physical checks to electronic deposits. Secretary-Treasurer Baumann noted that the SDAFS is holding funds for the Pollution Committee (\$1,800) and highlighted the issues that are encountered by committee's trying to establish individual bank accounts. The ending SDAFS balance for 2021 totaled \$42,878.46 and included \$13,273 in the strategic reserve funds.

An audit of the 2021 financial information was completed on January 10th, 2022 by the SDAFS Audit Committee Chair Kelsey Roberts. Due to COVID-19 precautions, the committee was unable to meet in person with all members present. The Audit Committee report can be found in the briefing book and there were no errors identified in the 2021 financials. The Division's original investment into AFS's managed investment program of \$10,000 in October of 2018 has grown to \$13,273 as of June 2021. It was noted that the Audit Committee Chair suggested the Division look into a more aggressive investment to complement our financial portfolio.

The proposed 2022 SDAFS budget was discussed. Secretary-Treasurer Baumann noted that typical levels of income and expenses were expected in 2022. Highlighted was the proposed donation to Past President Tom Kwak's children college funds.

The current bank balance is sufficient to maintain SDAFS operations.

Secretary-Treasurer Baumann brings forth the topic of how the society handles student rooms at the annual meeting and the need to decrease the number of students assigned to a room from four to two. This was received with general agreement from those in attendance.

Executive Director Austin highlighted the issue of enforcing AFS's code of conduct during annual society meetings. He stressed the importance of having a contact person at each meeting in which issues can be reported to onsite and then to make sure those issue are reported to AFS. Director Austin also stressed that AFS takes violations to the code of conduct very seriously.

A general discussion was held regarding the low turnout for student based elections and the low number of students that are also members of the Parent Society. Don Jackson suggested that the Division help fund student memberships through student awards and registration fees.
