Bayless Award for Best Professional Paper Andrew Ray, South Carolina DNR

Andrew Ray was announced as the winner of the 2008 Bayless Award at our Annual Meeting on February 12, 2009 at the Clemson University Outdoor Lab, SC. The award was for Andrew's presentation "Relationships between shrimp (*Litopenaeus vannamei*) growth parameters and microbial activity in zero-exchange culture systems" which he presented on February 4, 2008 at

the SC-AFS annual meeting at Santee State Park, SC.

The Bayless Award was created in honor of Jack D. Bayless, to recognize the best South Carolina presentation/paper given at each annual chapter meeting. Each year, volunteer judges evaluate presentations in the following categories:

- Significance to aquaculture and fisheries,
- Experimental design and analysis,
- Organization,
- Presentation, and
- Quality of visual aids.

Presenters are scored on a scale of one to four, four being excellent, for each category. The presenter with the highest total score receives the award. Any members interested in volunteering as judges for the next annual meeting, or joining the Awards Committee, should contact SC-AFS President or President-elect.



Conservationist of the Year Award

The Conservationist of the Year Award is presented periodically at the annual SC-AFS meeting. This is the most prestigious award bestowed by the SC-AFS Chapter and it recognizes outstanding contributions in the conservation of South Carolina fishery resources. 


Report of the joint SC-AFS and SCFWA Annual Meeting
