On November 5, 1975 this became a reality when over 100 fisheries workers and students attended a meeting at Texas A&M University. The objectives of the chapter are those as set forth in Article 1 of the AFS Constitution and to encourage the exchange of information by fishery workers residing within the State of Texas.

Ed W. Bonn (TP&WD) was elected President and James T. Davis (Texas A&M) was elected President Elect. Robert E. Stevens (TP&WD) was elected Secretary-Treasurer but resigned when he accepted a job with the National Marine Fisheries Service and moved to Washington, D.C. Terrance R. Leary (TP&WD) has agreed to do that job until our 1976 annual meeting.

A charter was drafted and has been submitted to the parent society for approval. It will be reviewed and acted upon at the society meeting in September. <u>Federal Legislation</u> - Probably the most significant fishery legislation in our history has passed both Houses of Congress in two versions of H.R.200. A redraft by a joint committee is expected to be passed and approved by the President this spring. H.R.200, among other provisions, would: Extend U.S. jurisdiction over fisheries to 200 miles; set up eight

regional councils to manage fisheries in this zone beyond present state jurisdiction; authorize the councils to provide management, licensing, and limited entry plans; provide for a five-state Gulf regional council composed of 15 voting members including the senior executive officer of each of the five Gulf States who is responsible for managing marine fisheries resources and ten appointed by the Secretary of Commerce from lists of five qualified individuals submitted by each Gulf State Governor. Non-voting council members would be regional directors of the National Marine Fisheries Service, Fish and Wildlife Service, Commander of the Coast Guard District, and the executive director of the Gulf States Marine Fisheries Commission.

The effective date is expected to be after January 1, 1977, though regional councils would be established earlier to commence planning.
