Responses to Bob Kendall's letter about our Chapter Proceedings

A letter from Bob Kendall of the AFS regarding our chapter proceedings was included in the last newsletter. In essence, the letter stated our Proceedings were grey literature and therefore not citeable in Transactions. Gary Carmichael requested member input, and received the following comments.

- 1. Resolve to request the managing editor of the AFS (B. Kendall) develop a system for circulating the chapters proceedings from the AFS central office. (request that the AFS support and serve the chapter).
- 2. Resolve to try to attract more good quality papers that will be cited. Other journals cite our proceedings (and have in the past). Build an argument that Texas Chapter Proceedings are already cited). In addition, improve the quality of the proceedings (type, margins, standard journal figure legends, etc.). Finally, get more libraries and the AFS to carry the proceedings.
- 3. Resolve to form the proceedings as a collection of Abstracts from the annual meeting. Accept papers from the annual meeting <u>and</u> accept papers other than those presented at the annual meeting. Adding this last aspect (other papers) will allow for the other good quality papers (improve quality and timing of papers).
- 4. Resolve to leave the proceedings as they are and quit bickering about the issue.

Senator Bentsen Responds to the Texas Chapter

In February, Joe Tomasso received a request from the AFS Southern Division EXCOM to write a letter on behalf of the Chapter to the Texas Congressional delegation to express disfavor with the Reagan Administration plan to transfer Wallop Breaux Revenues to general USFWS accounts. Joe drafted a letter, and the Chapter received a response from Senator Lloyd Bentsen. Senator Bentsen stated "I share your concern about the possible negative impact such a measure would have in the Wallop-Breaux trust fund, and I question the legality of the transfer". He further stated he would keep our comments in mind during budgetary hearings.
