COMMITTEE REPORTS

<u>Secretary/Treasurer:</u> Barbara Gregg reported the commercial checking account had \$4,875.41 and CD's of \$2,155.07.

Membership: Loraine Fries reported about 70 members have not renewed their membership. A list is provided as a reminder. There are 143 paid-up members.

Nominating: Bobby Whiteside reported that no nominations have been received for President-elect or Secretary/Treasurer for the 1992 term.

GRAY LITERATURE---AGAIN!

We finally received a response from Bob Kendall, Managing Editor, American Fisheries Society regarding the letter requesting a verdict on whether or not he would accept our annual proceedings as a formal publication. Following is an excerpt from his letter:

- "... Therefore, I approve the "Annual Proceedings of the Texas Chapter, American Fisheries Society" as a formal, citable publication within AFS--contingent on the Chapter meeting following additional requirements of the publications policy.
- (1) The Editorial Committee should send me, as Managing Editor, copies of each full manuscript under consideration for upcoming proceedings, prior to publication. I must approve these before they can be included in the proceedings. In practice, I will only require prepublication review for a year or so, until I gain confidence in the Chapter's quality control. Thereafter, I will only give a post-publication review until such time as I sense a lapse in quality control.
- (2) The Chapter should create a semipermanent publications office to which inquiries about and orders for the proceedings can be directed. It doesn't matter where it is, as long as there's someone there who will retain responsibility for matters relating to the distribution of the proceedings. A corollary is that the Chapter will need to establish a distribution, sale, and pricing policy for the proceedings.
- (3) Each volume of the proceedings should contain the following printed information:

- (a) an International Standard Serial Number (ISSN), which I will obtain for you;
- (b) the year of actual publication of the proceedings, whether or not publication occurs in the same year the meeting was held;
- (c) the name of the publisher (Texas Chapter) and the publisher's address--see (2) above.
- (4) One copy of each volume should be sent to at least the following:
 - (a) Serial Sources for the BIOSIS Previews Data Base 2100 Arch Street Philadelphia, Pennsylvania 19103-1399
 - (b) Executive Director
 American Fisheries Society

 Bethesda, Maryland 20814
- (c) Managing Editor, American Fisheries Society Send additional copies to whomever you think might archive, abstract, or otherwise help to publicize the existence of the proceedings..."

Kendall has requested a formal response to these conditions, which will be sent following the spring EXCOM meeting. Should you have any comments or suggestions regarding the conditions he has outlined, please send them no later than March 15 to:

Remember, now that our annual proceedings will be a formal, citable publication, authors will still be able to choose whether or not they wish to have their paper published there. Papers can still be presented, their abstracts published in the proceedings, and the papers published elsewhere.
