TEXAS CHAPTER ANNUAL MEETING
September 24 - 25, 1992
Camp Rio Vista - Kerrville, Texas

The Annual Meeting of the Texas Chapter of the American Fisheries Society will be held at Camp Rio Vista near Kerrville on the 24th and 25th of September 1992. Rio Vista includes over 1,000 feet of riverfront on the Guadalupe River. The road to the camp is dirt and you will cross on the top of fa low water dam (They promise that it is safe when the river is not flooding). Camp Rio Vista has fishing, canoes, swimming hole with rope swing, softball field, volleyball areas, 8 tennis courts (2 lighted), a 9-hole chip-and-put golf course (greens have just been mowed) and use of their sports equipment or bring your own (We really ought to meet here more often!). Included is a map of Kerr County showing Kerrville and Camp Rio Vista. For you to find Kerrville, first get your state map and locate San Antonio and then follow I-10 northwest. Write your own direction on the upper right hand corner of the map.

(complete bedroll - pillows, sheets and blankets along with washcloths, toiletries and towels). The beds have a mattress with cover and that is all. It is dormitory style with about 6 to 20 people per cabin, so pick your roommates before you come (and YES BRUCE that means men and ladies in separate buildings).

A \$25.00 participant fee includes overnight lodging, lunch on Thursday and breakfast on Friday. Thursday supper will be extra, around \$8 to \$10 and isn't mandatory (You can go eat in Kerrville and see the sights). There is also \$8.00 for the Texas Chapter AFS dues. (Total now is \$8.00 for annual dues and \$35.00 for 3 meals, one overnight stay and all the fun you can cram in - - so get your friends to sign up and come with you!).

The agenda includes registration beginning about 10 am on Thursday, the technical sessions will be Thursday afternoon. We also plan to have the traditional auction Thursday after the evening meal - outside if weather permits. The Friday morning
